# **ARCEE**

#### Appalachian Residential Consortium for Energy Efficiency

The name might sound strange, but the work behind the name is extremely important for Home Builders, consumers and the housing industry in West Virginia and the rest of Appalachia.

#### The Situation

When you buy a new car, you expect the vehicle to have the newest technology and the best safety features available.

When you buy a new home, you expect that the latest technology and the most modern methods have been used in its construction.

That may be true of the appliances in the home or the smart house technology, but the reality is that the actual methods used in the construction of the home have changed very slowly, especially in West Virginia.

Even though the state adopts a residential building code, it is not enforced in most of the state. Currently only 15% of West Virginia jurisdictions have residential construction code officials and code enforcement. The remaining 85% of the state has no residential code enforcement. This is due in part because the state is composed of largely rural areas without code officials.

The lack of code supervision has resulted in a large number of residential builders who "have no clear external standard that will help them build a home that conforms to the 2009 energy code" said Sheila Coleman-Castells, project manager for ARCEE.

"To address this challenge, and to protect our members and our clients. we need clear, comprehensive and systematic instruction," said Coleman-Castells. "ARCEE will provide this and more to HBA members free of charge, funding permitting."

A new construction home using the 2009 building code as opposed to the 2003 code, will see a \$2,000 savings in energy costs over a two year period, according to the US Department of Energy figures based on the current cost of utilities in West Virginia.

#### The Code

The 2009 International Energy Conservation Code (IECC) was adopted in West Virginia as the state energy code for residential construction and went into Now, thanks to the efforts of the North Central Home effect September 2013. Prior to that time, the state building code for residential construction was based on the 2003 International Residential Code (IRC).

There is significant difference between the 2003 and the 2009 codes, and that difference is basically in methods used to foster energy efficiency.

A new construction home using the 2009 building code as opposed to the 2003 code, will see a \$2,000 savings in energy costs over a two year period, according to the US Department of Energy figures based on the current cost of utilities in West Virginia.

#### A New Way Of Doing Things

Because the requirements of the new building code are so dramatically different from the way things used to be done, there is a need to train residential builders in new techniques and procedures.

"The house building science is so different from what it was just a few years ago," said Dale Oxley of Modern Home Concepts in an interview with the Charleston Gazette earlier this year. Oxley is currently 2<sup>nd</sup> Vice President of the HBA of WV and a Home Builder member in the Greater Charleston area.

Oxley had to go out of state to receive training in the 2009 code back in 2010 and 2011. The National Association of Home Builders (NAHB) has offered certifications for Green Professionals for years, but the cost of this training and travel to receive it, has

> made this training out of reach for many small residential builders.

> There are a large number of contractors in West Virginia who have not received such training and who continue to build using old techniques.

> The WV Department of Commerce Energy has provided training across the state for the last two years to try to bring

residential builders up to speed, but the process of training has been slow.

Builders Association, the Home Builders Association of West Virginia and the WV Home Builders Association Charitable Fund (WVHBACF), ARCEE has been

created to train and certify HBA members in energy efficient building techniques. This will give members the tools they need to build and design new homes in a more energy efficient way, and it will give consumers confidence in knowing their contractors have been certified and are capable of providing the best value in energy efficiency and technology for their new home.

This training is scheduled to begin in the last quarter of 2015 and will be offered not only to WV residential builders, but to builders in surrounding areas as well.

#### The Training

The first level of training will be for residential builders. Those who complete the training and test will understand how to build a "tight" house that can pass a blower door test. That means that the house is designed to reduce air leakage while preventing moisture build up. Builders will learn how to adjust framing and how to properly seal a home. They will be introduced to the abundance of new products and new techniques of construction.

"The 2009 code is an important standard to meet." and we want to make sure that the home builders understand what they need to do and that they are getting the best training available," said Coleman-Castells.

"We're building a lot of accountability into this training," she added. Those who take the class will be certified with a test. As a result, the consumer will have clear confidence that their builder knows what they are doing.

This education effort from ARCEE will make training more attainable for all residential builders in the state. The goal is to create large-scale training with little or no cost to the home builder. These builders are generally small businesses constructing five to 10 homes a year.

A second prong of the training will be directed to Realtors, appraisers, architects, code officials and bankers. All of these people need to understand the new code and the value of energy efficiency.

#### The Consumer

The next part of the equation is the education of the consumer through a public awareness campaign and targeted marketing efforts. This will be designed to educate the consumer on the importance of energy efficiency so they can make informed decisions. Included in this effort will be a web-based resource to assist the consumer in locating certified contractors.

Energy efficiency not only saves money, but it provides a healthier living environment. The US Department of Energy "has research that a more energy efficient home is a healthier place for children and families," said Coleman-Castells. "We want homes to be healthy and safe," she added.

"If a house is too hot or cold, it can cause a number of physical problems such as respiratory issues," she said. Add moisture to the mix and there can be mold

and additional problems. This can take a toll on children and the elderly."

West Virginia has some of the highest disease rates in the nation," she said. "Our population is among the oldest and sickest, and a large number of our children live in poverty."

This past year the number of households in WV who received assistance with heating or cooling

bills through the federal assistance program LIHEAP jumped 20%, from 77,000 to 90,000. When you consider that the cost of energy is going to continue to rise, energy conservation and energy efficiency become increasingly important.

While the code updates apply only to new homes, what is built in the coming years will have an impact for future West Virginia homeowners, Coleman-Castells said.

The impact will eventually be seen in the older housing stock, because builders do a lot of different types of jobs besides new construction, she added. Many of the skills they use in new construction can be translated into remodeling projects as well.

Once a sufficient number of builders have received training and become certified, a resource list will be made available to the consumer. They will be able to go online and find residential builders who are willing to work in their zip code.

#### The Project

The purpose of ARCEE is to provide "a HIGH-quality, HIGH-comfort energy efficient home at a LOW-energy cost for our hard working families."

Other states have tackled similar programs, but have funded it by taxing the energy bills of their people or using government funding. West Virginia is the only Appalachian state to work on this issue, and they are doing so without using federal funding or being a burden to the consumer.

ACREE is a non-profit effort through the WV Home Builders Association Charitable Fund and will not cost the tax payer or the consumer anything.

ACREE is currently funded by grants from the Claude Worthington Benedum Foundation and the 84 Lumber Corporation.

Jeff Herholt, director of the WV Division of Energy, has been a key ally and an invaluable help, said Coleman-Castells. He has been instrumental in the production of a professional training video, as well as a liaison to open doors for this program.

Discussions are also in process to possibly link ARCEE to the National Green Building Standard

through the Home Innovation Laboratories (formerly known as the NAHB Research Labs).

Additional facets of this program will address appraisal models and access to energy efficient mortgage money.

"We believe that this project will help improve the overall quality of home building and energy conservation in ways that give professionals the time and critical expertise needed to adapt to the changing standards," said Jacob S. Meck, builder in Pocahontas County and President of the HBA of WV. "This serves both the consumer, the HBA member, the real estate industry, and our state in positive ways."



# Summary of Proposed HBAWV Bylaws Changes

This is an overall update of the bylaws. The entire bylaws may be voted on at the October Board meeting. All proposed changes can be viewed on our web site. The proposed changes are shown in red on the web site. Listed below are summaries of the major changes proposed.

ARTICLE I Sec 2 (a) Builder membership is changed to include anyone whose business is or was building, remodeling, land development, commercial construction and this person must possess a valid WV Contractors License if required by the area in which they operate. (Clarified who can be builder members, but could also include a Handyman).

ARTICLE III Sec 1 Dues shall increase at the rate of 3% per year unless otherwise changed by the Board of Directors. If dues are to be changed, notice of the proposed increase shall be circulated at least 10 days in advance of the meeting at which this change is to be considered. (Clarified language and removed actual dues amounts from the bylaws.)

ARTICLE VI Sec (e) is deleted; this section had the Board of Directors electing BUILD PAC Trustees. (The BUILD PAC Trustees are elected by the BUILD PAC contributors, not by the Board of Directors.)

ARTICLE VI Sec 2(c) Change the name of Associate Treasurer to Assistant Treasurer.

ARTICLE VI Sec 4 Change the title of our chief administrative office from Executive Officer /Vice President to Executive Officer.

**ARTICLE VII Sec 2(b)** Changes proxy votes by requiring a Board Member to have attended 2 meetings during the past year in order to be eligible to have their vote cast by proxy. (The intent of this change is to limit proxy votes to Board Members who have met their qualifying attendance; which is 2 meetings a year.)

ARTICLE IX Sec (1) Changes to allow at any meeting of the executive committee to be attended by approved electronic methods. (The current wording leaves this at the discretion of the President.)

# **HBA Advocacy**

One of the primary benefits of membership in the Homes Builders Association is the work that is done locally, at the state house and in Washington DC in advocating for the residential construction industry.

Most people are not aware of the multitude of laws and rules that are proposed each year and the impact they would have on individual contractors and suppliers as well as the cost of housing for the consumer.

Housing touches almost every sector of the economy, and the decisions made ultimately impact everyone, whether they rent or own their home.

#### WV Advocacy

In West Virginia, the Executive Officer Beth Thomasson is also the registered lobbyist. For over 25 years she has been the voice of home builders and is extremely respected by all who know her. She understands the legislative process and has worked tirelessly to share insight with the legislators, state

officials, as well as HBA members and to work out solutions for difficult questions.

When the state legislature is in session, she spends endless days and nights in committee meetings and in individual conversations with Beth Thomasson, legislators regarding proposals that Executive Officer/ impact the association's members.



Lobbyist

These issues vary from Codes and Contracts, Contractor Licensing issues, Taxes, Job Creation and Economic Development, Fraud and Ethics, Wages and Labor issues, OSHA safety requirements for construction projects, Small business employee issues, Landlord/Tenant issues, Mechanics Liens and many others.

The HBA WV Government Affairs committee works with Thomasson, discussing issues at board meetings, making trips to the state house when testimony is needed and contacting representatives on issues as they arise.

Thomasson has an email network developed to keep members abreast of issues between meetings, and

their status throughout the session. HBA members and subcommittees work with Thomasson and state congressional interim committees to propose solutions between sessions.

Lobbying is not the only activity of the association. Members are represented on boards such as the Contractor Licensing Board and others have served on other boards such as the WV Housing Development Fund through the years.

Several members serve on boards and planning commissions in their local areas. This makes a difference for the industry.

In years past, the association has held a legislative reception for legislators during session. This has given members of the association the opportunity to talk one-on-one with their representatives. This allows them to serve as a resource for legislators and gives members a better understanding of the dynamics at work in various situations.

This year as a change of pace, the HBA of WV joined with several other agencies and groups to host "Housing Day at the Legislature" on Feb. 27. Members of the HBA met with representatives and provided to them box lunches and a program. The organizations set up displays, giving the legislators the opportunity to visit and ask questions.

Master of Ceremonies for "Housing Day" was

Douglas Scaff, Kanawha County Delegate. Included in the program was the WV Community Action Partnership, Mary Chipp, Executive Director. She was followed by Tammie Alexander. President of Habitat for Humanity WV. who announced the Affordable Housing Hall of Fame Inductee.

Subjects for discussion included the housing outlook for 2014, tax reform, housing finance reform, labor shortage & immigration reform, flood insurance reform, energy codes, and lead paint regulations.

In April the HBA of WV board was alerted to the ramifications of the new Mechanics Lien legislation that was to go into effect at the beginning of June.

Associate members (those who supply materials and related services for contractors) were concerned that the last minute changes that were made to HB-4347 left them with no recourse to receive just compensation for materials and services rendered.

Details of what happened can be found in the editorial by our Executive Officer, Beth Thomasson on page 18. Several meetings have been held to help craft legislation that will be fair for both the consumer as well as the builder and the supplier.



Suppliers met with HBA members to discuss optional approaches regarding the Mechanics Lien in Flatwoods in July.

Members have been given several opportunities this year to hear from elected officials. In January, the board was addressed by Senator Joe Manchin with an overview of activities happening in Washington that relate to the residential construction industry, with an opportunity to ask questions.



In July, WV Attorney General Patrick Morrisey spoke regarding initiatives to hold the Federal government accountable in their rules and regulations, especially as they affect West Virginians.

#### The Fight To Keep Our Mechanics Lien

That is the challenge that Jay Harper (Harper Lumber Co. in Buckhannon) gives in all his correspondence - and it's working. As awareness of the consequences of HB 4347 began to filter among building suppliers that their right to file a mechanics lien (after 37 years) was to end as of June 8<sup>th</sup>, the troops came marching in.

The HBA, along with the Builders Supply Association (both associations share many of the same members), had an emergency meeting at the HBA office.

With June 8<sup>th</sup> just days away, the first priority was to determine how to stop the effective date. The only option was to prevail upon the Governor and his staff to place a bill on his special session in May, before June 8. This was not an easy task, but one we were able to achieve. We worked tirelessly with Governor Tomblin and his staff to present our case.

Background Note: You need to understand that this bill was a concern for most of the 60 days of the last legislative session. It took so many wrong turns during its journey and the problems were so many. We had to tackle them one at a time -AND time ran out at the end of session with the biggest problem yet to be solved.

Our request to the Governor was to extend the effective date to the end of the 2015 session. We felt that extension would give us time to have proposals to present to legislators next year. Our goal is to return a supplier's lien rights while still protecting the home owner and the contractor.

We were very pleased when we learned that a bill would be on the special session agenda - and even more pleased that the effective date would be July 15, 2015.

With that behind us, two meeting have been held to strategize. By the time you read this article, a bill will have been drafted and circulated for approval of the group.

The next step is to begin talking with legislators to lay out the plan. (During the past few weeks we have received support from quite a few and have focused our efforts on key leadership).

It is our hope that we will have a bill ready for introduction early in the 2015 session - a bill that is fair to the homeowner, the contractor and the supplier and that there will be 134 GREEN lights.

#### SERMON TIME --

We continually talk about recruiting and the advantage of membership. I think I've just given you the best example we will ever have. Information on the ramifications of HB 4347 was sent to members in various legislative reports and newsletters.

To the many non-member building supply companies and sub-contractors throughout the state who have no lines of communication - it's not hard to imagine their surprise and frustration in filing a lien, attempting to perfect their lien, (had this legislation been effective this past June) and then finding that thousands of dollars had just gone down the drain.

I think I can stop right here. Don't forget, also, to tell your prospective members the many other advantages and member discounts available. Let us know how many "Advantages of Membership" brochures you need.

Dear Home Builders & Associate Members,

I trust this finds you in the busiest time of year with an abundance of work to wrap up before the winter season is upon us.

As I speak to a number of you on occasion across the state, it appears that the struggling economy is behind us and the promise of large amounts of work lay ahead. As we ponder the change from less work to more work, it comes with a different set of challenges.

As a business owner, I commonly find the day becoming much shorter than the time needed to complete the tasks. We commonly consider an increase in hiring to help with the work load. However we struggle to delegate the tasks efficiently and maintain quality, which is a direct reflection on who we are and what we have based and grown our companies upon.

I was recently speaking to a supplier who manages a number of employees and could tell his day was going much like mine.

Upon chatting for several moments and hearing the frustration in his voice, I asked him the following question. "Was his staff doing exactly what he had envisioned in his mind, or had he failed to adequately communicate to them verbally?"

Many times as owners and managers, we find ourselves in this position—failure to communicate delegated tasks. Commonly, the end result is that jobs are not completed, they are given to the wrong person, they are improperly constructed, or any number of other deficiencies.

I recently read an article titled

"The Steps of Successful Delegation."

- **1.** <u>Define the task</u> Confirm in your mind that the task is suitable to be delegated. Does it meet the criteria for delegating?
- 2. <u>Select the individual or team</u> What are your reasons for delegation to this person or team? What are they going to get out of it? What are you going to get out of it?
- **3.** Access ability and training needs Is the other person or team of people capable of doing the task? do they understand that needs to be done? If not, you can't delegate.
- **4.** Explain the reasons You must explain why the job or responsibility is being delegated and why to that person or people. What is its importance and relevance and where does it fit in the overall scheme of things.
- **5. State the required results** What must be achieved? Clarify by getting feedback from the other person. How will the task be measured? Make sure they know how you intend to decide that the job is being successfully done.
- **6.** <u>Consider resources required</u> Discuss and agree what is required to get the job done. Consider people, location, premises, equipment, money, materials, and other related activities and services.
- **7.** <u>Agree on deadlines</u> When must the job be finished? Or if it is an ongoing duty, when are the review/ report dates? If the task is complex and has parts or stages, what are the priorities?
- **8.** Support and communicate Think about who else needs to know what is going on and inform them. Involve the other person or persons in considering this, so they can see beyond the issue at hand. Do not leave the person to inform other management of their new responsibilities.
- **9. Feedback on results** It is essential to let the person know ho they are doing and whether they have achieved their aims. If not, you must review with them why things did not go to plan, and deal wit the problems. You must absorb the consequences of failure, and pass on the credit for success.

I wish each of you continued success as you grow your business in the months ahead.



#### **Advocacy** Continued

This has been just an overview of the major activities this year on behalf of home builders around the state. In addition to these statewide efforts, the NAHB has made a significant impact this year to save builders money and effort by intervening on their behalf in the development of national regulations. The following is a brief summary of victories due to NAHB advocacy this year.

- EPA drops post-construction stormwater rule
- US Supreme Court Clean Air Act ruling benefits multi-family builders. The EPA tried to require multi-family builders to get pre-construction permits for greenhouse gases generated by the buildings they construct.
- Costly provisions to building codes were kept out of the code, representing a substantial savings in construction costs.
